ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.55 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.55 per Offer Share and the total number of 100,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company (after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Share Offer) are estimated to be approximately HK\$31.0 million (equivalent to approximately RMB26.7 million). The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 15,457 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider via the **HK eIPO White Form** service for a total of 626,655,000 Public Offer Shares, representing approximately 62.67 times of the 10,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- As the over-subscription in the Public Offer is more than 50 times but less than 100 times, the reallocation procedure as disclosed in the paragraph headed “Structure and Conditions of the Share Offer — the Public Offer — Reallocation” in the Prospectus has been applied and a total of 30,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. The final number of Offer Shares under the Public Offer is 40,000,000 Offer Shares, representing 40% of the total number of the Offer Shares initially available under the Share Offer (without taking into account any Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme), and being allocated to 5,948 successful applicants under the Public Offer.
- The Directors confirm that, to the best of their knowledge and belief having made all reasonable enquiries, none of the Public Offer Shares subscribed has been financed directly or indirectly by any of the directors, chief executive, controlling shareholders, substantial shareholders or significant shareholders (as defined under the GEM Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined under the GEM Listing Rules), and none of the subscribers of the Public Offer Shares is accustomed to taking instructions from any of the directors, chief executive, controlling shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.

Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed. The total number of subscriptions under the Placing was 93,905,000 Placing Shares, representing approximately 1.04 times of the 90,000,000 Placing Shares initially available for subscription under the Placing. The final number of Placing Shares allocated to 112 placees under the Placing is 60,000,000 Placing Shares, representing 60% of the total number of Offer Shares initially available under the Share Offer (without taking into account any Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme).
- Among the Placing Shares to be allotted and issued, an aggregate of 6,615,000 Offer Shares, representing 7.35% of the 90,000,000 Placing Shares initially available for subscription under the Placing, were placed to two individuals who were beneficial owners of two customers of the Group during the Track Record Period, respectively. The Directors confirm that each of such individuals is an Independent Third Party.
- Save as disclosed above, the Directors confirm that, to the best of their knowledge and belief having made all reasonable enquiries, all placees under the Placing and their ultimate beneficial owners are independent of and not connected with the Company and any of the directors, chief executive, controlling shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries, and their respective close associates, and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Placing Shares subscribed by the placees has been financed directly or indirectly by any of the directors, chief executive, controlling shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees is accustomed to taking instructions from any of the directors, chief executive, controlling shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. None of the Sole Sponsor, the Sole Bookrunner, the Sole Lead Manager, the Co-lead Managers and the Underwriters or their respective close associates or connected clients of the lead broker or of any distributors (as defined in Rule 10.12(4) of the GEM Listing Rules) has taken up any Offer Shares for its own benefit under the Share Offer. No placee, individually, has been or will be placed more than 10% of the enlarged issued share capital of the Company immediately after completion of the Capitalisation Issue and the Share Offer. The Directors confirm that there will not be any new substantial Shareholder of the Company within the meaning of the GEM Listing Rules immediately after completion of the Share Offer and Capitalisation Issue, and that there will be at least 100 Shareholders at the time of Listing in compliance with Rule 11.23(2) of the GEM Listing Rules, and the three largest public Shareholders will not beneficially own more than 50% of the Shares in public hands at the time of Listing in compliance with Rule 11.23(8) of the GEM Listing Rules. The Directors also confirm that the number of Shares in public hands will satisfy the minimum percentage requirement prescribed by Rule 11.23(7) of the GEM Listing Rules that at least 25% of the total issued share capital of the Company will be held in the hands of the public.

Cornerstone Investor

Based on the Offer Price of HK\$0.55 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), and pursuant to the cornerstone investment agreement entered into among the Company, the Sole Bookrunner and the Cornerstone Investor, the number of Shares to be subscribed by the Cornerstone Investor will be 16,360,000 Offer Shares, representing (a) approximately 18.2% of the total number of the Placing Shares initially offered under the Placing; and (b) approximately 4.1% of the Company's issued share capital immediately upon completion of the Capitalisation Issue and the Share Offer (without taking into account any Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme). INDICATION OF INTERESTS RECEIVED UNDER THE PLACING

The Placing Shares initially offered under the Placing have been slightly over-subscribed. The total number of subscriptions under the Placing was 93,905,000 Placing Shares, representing approximately 1.04 times of the 90,000,000 Placing Shares initially available for subscription under the Placing. The final number of Placing Shares allocated to 112 placees under the Placing is 60,000,000 Placing Shares, representing 60% of the total number of Offer Shares initially available under the Share Offer (without taking into account any Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme).

A total of 61 placees have been allotted eight board lots or less of Placing Shares or less, representing approximately 54.46% of the total number of placees under the Placing. A total of 2,440,000 Placing Shares have been allotted to these placees, representing 4.07% of the 60,000,000 Placing Shares after reallocation to the Public Offer.

CORNERSTONE INVESTOR

Based on the Offer Price of HK\$0.55 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), and pursuant to the cornerstone investment agreement entered into among the Company, the Sole Bookrunner and Differ Group Holding Company Limited (the “**Cornerstone Investor**”), the number of Shares to be subscribed by the Cornerstone Investor will be 16,360,000 Offer Shares, representing (a) approximately 18.2% of the total number of the Placing Shares initially offered under the Placing; and (b) approximately 4.1% of the Company’s issued share capital immediately upon completion of the Capitalisation Issue and the Share Offer (without taking into account any Shares to be issued upon the exercise of options which may be granted under the Share Option Scheme).

To the best knowledge of the Company, the Cornerstone Investor is independent of the Company, its connected persons and their respective associates. The Offer Shares to be subscribed for by the Cornerstone Investor will rank pari passu in all respects with the other fully paid Shares in issue and will count towards the public float of the Shares under Rule 11.23(7) of the GEM Listing Rules. Immediately upon completion of the Capitalisation Issue and the Share Offer, the Cornerstone Investor will not have any representation in the Board or become a substantial Shareholder of the Company.
