- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓 證券;
- 存置或更新本公司證券持有人的名冊;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如 股息、實物分派、供股、公開發售和紅股 等:
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;
- 遵照法例、規則、守則或規例的規定作出 披露;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的 及/或使本公司及香港股份過戶登記分處 能履行對證券持有人及/或監管機構承擔 的責任及/或證券持有人不時同意的任何 其他目的。

3. 轉交個人資料

- 向本公司或香港股份過戶登記分處提供 與其各自業務營運有關的行政、電訊、電 腦、付款或其他資料處理服務的任何代理 人、承包商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關 或政府部門、行政機關或法院或遵照其他 法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何 人士或機構,例如彼等的銀行、律師、會 計師、獨立財務顧問或持牌證券商等。

4. 個人資料的保留

5. 查閱和更正個人資料
